and I specifically affirm that I am not compromised in any manner that would affect the performance of my duties and  
Oath of Office.
2. I, affiant, have taken and maintained the following Oath of Office as found in 5 USC §3331: "I, **Margaret Wood Hassan**,  
do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies,  
foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without  
any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on  
which I am about to enter. So help me God."
3. I, affiant, after making my Oath of Office, personally signed my name in the bound Oath Book, and affirm that I have  
met all the criteria required to be lawfully in office, and my credentials as Senator-elect are laid down en bloc and  
ordered printed in the Congressional Record.
4. I, affiant, in demonstration of good faith to We The People, and to remove any vagueness, confusion or doubt as to  
what I meant by using the word "discharge" in my Oath of Office, I hereby define and declare "discharge" to mean  
"accept and fulfill" in my Oath of Office.
