We The People will lawfully hold you personally liable for damages for every day you claim to be in office representing us and for any action you take while in breach of your fiduciary duty to us, which is our right to do as we seek our lawful relief and remedy so that all can be made whole, without having to convene an Article V constitutional convention. We The People cannot presume that you agree to any of the following unless you objectively, explicitly, and verifiably affirm that you agree to the following: to the following:
