I, Rocky Diesel, as a representative of We The People as the body politic of the unanimous Declaration of the thirteen united States of America: the sentient living men and women of the Republic and the United States of America, hereby peacefully require your answers to the following questions, which should be self-evident in keeping with your Oath of Office as one of our public servants. If you choose not to or cannot provide your answers to us timely, or give us points and authorities in law that provide lawful reasons as to why you cannot do so, we will take it as your Tacit Agreement that you are refusing to uphold your Oath of Office which constitutes a refusal of Office, and you therefore cannot, and do not, lawfully represent We The People, and cannot hold office. We The People will lawfully hold you personally liable for damages for every day you claim to be in office representing us and for any action you take while in breach of your fiduciary duty to us, which is our right to do as we seek our lawful relief and remedy so that all can be made whole, without having to convene an Article V constitutional convention. We The People cannot presume that you agree to any of the following unless you objectively, explicitly, and verifiably affirm that you agree to the following:

- 1. Do you agree that, All sentient living men and women were created by our Creator and are conceived and born free, endowed by our Creator with Unalienable Rights, such as the unfettered right and freedom in all religious and health decisions and actions for ourselves and our families?

2. Do you agree that, We The People created our government as a Republic, with the clear condition that our consent to governance came with the requirement of government transparency and accountability to us by our public servants?

3. Do you agree that, the United States Constitution is the Public Trust Contract between We The People as beneficiaries and our civil servants taking office as our public servants in civil service under the restraints of the United States Constitution and State Constitutions, and We The People are entitled to honest services from all our public servants?

4. Do you agree that, providing honest services as public servants of We The People includes but is not limited to, members of any State or Federal Congress first reading and understanding any new law applicable to We The People before voting for or against it, and that laws passed must also apply to members of Congress?

Do you agree that, no public servant shall create or participate in, or allow to continue, any form of slavery, involuntary servitude, human trafficking, or any form or type of voluntary servitude wherein any document, decree, or contract created by government compels a Citizen to do or not do something through intentional semantic deceit, fraud, coercion, duress, misleading information, incomplete disclosure, non-disclosure of a material fact, or any other unlawful or illegal abusive tactic, or tyrannical action, which violates any Citizen's Unalienable Rights and that public servant's Oath of Office?

6. Do you agree that, We The People have the Unalienable Right and Duty to inquire and ask questions to our public servants, and public servants have a lawful Duty to timely respond and give true and complete answers to us, and their deliberate failure to do so is criminal interference of a government process?

7. Do you agree that, it is the Unalienable Right and Duty of We The People to hold our public servants accountable to their fiduciary Duty to us through their constitutionally required Oath of Office, and we are lawfully entitled to a redress, remedy, and recourse if any of our public servants violate their Oath of Office?

Do you agree that, an individual must complete all the requirements to be lawfully in public office as a civil servant, and they are personally liable if they have not made or properly maintained their Oath of Office, or if they break their Oath of Office, and their personal assets are subject to lien if they do not have a sufficient personal responsibility bond or surety bond to cover all damages owed?

13. Do you agree that every contract, written or verbal, presumed or assumed, is null and void ab initio if entered by a Citizen through fraud, intentional semantic deceit, coercion, duress, or if there was a non-disclosure or an omission of a material fact?

14. Do you agree that, it is an Unalienable Right of a Citizen to lawfully challenge, refute and rebut any presumption or assumption of any court, law, or contract, and all courts must respect that right?

Do you agree that, only laws made according to the United States Constitution and State Constitutions are actual laws that apply to We The People, and all laws made by any Congress that have regulations incorrectly promulgated under them are not enforceable and have no legal effect, and any public servant depriving the right of a Citizen by enforcing regulations under Color of Law, knowingly or unknowingly, commits a felony offense?

Do you agree that, words have specific meaning when used in law, and changing the definitions of words used in a law potentially changes the law itself, and therefore the correct interpretation of the plain wording of the law itself necessarily requires the use of the applicable legal definitions of the words used in the law from the time the law was created.

18. Do you agree that, members of any State or Federal Congress, as public servants of We The People, were not given the authority to change the meanings of words in laws made by a previous Congress, because this would potentially violate the intent of the Congress that originally made the law?

Do you agree that, even though the Legal Context use of the word "discharge" means "Release from Obligation: The fulfillment, cancellation, or annulment of a legal duty, such as the discharge of a debt or a contractual obligation" or "Dismissal: The formal release of an individual from employment, military service, or legal custody", when you took your Oath of Office, you meant the word "discharge" to mean "accept and fulfill" your duties, and you would support the replacement of the word "discharge" with the words "accept and fulfill" in the required Oath of Office?

Do you agree that, any negotiable instrument or other form of contract, created by public servants or agencies or agents under them, is unlawful, null and void ab initio if it is misleading or, uses intentional semantic deceit, or fails to disclose a material fact, and results in creating or effecting any form of unconstitutional voluntary servitude, or other harm, to any free, living man or woman?

Do you agree that, any member of any State or Federal Congress violates their Oath of Office, if after written notice of such violation, deliberately continues to violate an Unalienable Right of We The People, further enumerated and protected in the United States Constitution, and any member of Congress or other public servant in office that deliberately violates their Oath of Office is making a deliberate refusal of office, which must result in their removal from office, because it is a felony offense for a member of Congress to knowingly and unlawfully deprive a right of a Citizen?

Do you agree that, any corporation engaged in the verifiable and sustained practice of undermining our original Declaration of Independence and Bill of Rights, through coercion, or misleading information, or intentional semantic deceit, or selective prosecution, or election fraud, or any other unconstitutional act, is subverting the Unalienable Rights of the living men and women, and is, in fact, an enemy of the We The People, and its officers are at war with We The People and engaged in Treason?

Do you agree that, if a public servant compels a Citizen to commit a crime or advises or coerces any Citizen to do so, or hinders or deprives the Citizen of their right and duty to report a felony crime they witness and make a criminal complaint, that public servant is committing a criminal act, such as the felony crime of Misprision of felony, which involves concealing knowledge of a felony without reporting it to the authorities?
