I, Rocky Diesel, as a representative of We The People as the body politic of the unanimous Declaration of the thirteen united States of America: the sentient living men and women of the Republic and the United States of America, hereby peacefully require your answers to the following questions, which should be self-evident in keeping with your Oath of Office as one of our public servants. If you choose not to or cannot provide your answers to us timely, or give us points and authorities in law that provide lawful reasons as to why you cannot do so, we will take it as your Tacit Agreement that you are refusing to uphold your Oath of Office which constitutes a refusal of Office, and you therefore cannot, and do not, lawfully represent We The People, and cannot hold office. We The People will lawfully hold you personally liable for damages for every day you claim to be in office representing us and for any action you take while in breach of your fiduciary duty to us, which is our right to do as we seek our lawful relief and remedy so that all can be made whole, without having to convene an Article V constitutional convention. We The People cannot presume that you agree to any of the following unless you objectively, explicitly, and verifiably affirm that you agree to the following:

1. Do you agree that, All sentient living men and women were created by our Creator and are conceived and born free, endowed by our Creator with Unalienable Rights, such as the unfettered right and freedom in all religious and health decisions and actions for ourselves and our families?

2. Do you agree that, We The People created our government as a Republic, with the clear condition that our consent to governance came with the requirement of government transparency and accountability to us by our public servants?

Do you agree that, the United States Constitution is the Public Trust Contract between We The People as beneficiaries and our civil servants taking office as our public servants in civil service under the restraints of the United States Constitution and State Constitutions, and We The People are entitled to honest services from all our public servants?

Do you agree that, providing honest services as public servants of We The People includes but is not limited to, members of any State or Federal Congress first reading and understanding any new law applicable to We The People before voting for or against it, and that laws passed must also apply to members of Congress?

Do you agree that, no public servant shall create or participate in, or allow to continue, any form of slavery, involuntary servitude, human trafficking, or any form or type of voluntary servitude wherein any document, decree, or contract created by government compels a Citizen to do or not do something through intentional semantic deceit, fraud, coercion, duress, misleading information, incomplete disclosure, non-disclosure of a material fact, or any other unlawful or illegal abusive tactic, or tyrannical action, which violates any Citizen's Unalienable Rights and that public servant's Oath of Office?

6. Do you agree that, We The People have the Unalienable Right and Duty to inquire and ask questions to our public servants, and public servants have a lawful Duty to timely respond and give true and complete answers to us, and their deliberate failure to do so is criminal interference of a government process?

7. Do you agree that, it is the Unalienable Right and Duty of We The People to hold our public servants accountable to their fiduciary Duty to us through their constitutionally required Oath of Office, and we are lawfully entitled to a redress, remedy, and recourse if any of our public servants violate their Oath of Office?

15. Do you agree that, all courts must assume and presume the innocence of the living man and woman who is privately exercising their right to freely engage in lawfully activities, until they are lawfully proven to have done harm to another sentient living being?

Do you agree that, only laws made according to the United States Constitution and State Constitutions are actual laws that apply to We The People, and all laws made by any Congress that have regulations incorrectly promulgated under them are not enforceable and have no legal effect, and any public servant depriving the right of a Citizen by enforcing regulations under Color of Law, knowingly or unknowingly, commits a felony offense?

Do you agree that, any corporation engaged in the verifiable and sustained practice of undermining our original Declaration of Independence and Bill of Rights, through coercion, or misleading information, or intentional semantic deceit, or selective prosecution, or election fraud, or any other unconstitutional act, is subverting the Unalienable Rights of the living men and women, and is, in fact, an enemy of the We The People, and its officers are at war with We The People and engaged in Treason?

Do you agree that, if a public servant compels a Citizen to commit a crime or advises or coerces any Citizen to do so, or hinders or deprives the Citizen of their right and duty to report a felony crime they witness and make a criminal complaint, that public servant is committing a criminal act, such as the felony crime of Misprision of felony, which involves concealing knowledge of a felony without reporting it to the authorities?
